1st prosecution witness. Sworn on the Koran and states in English language the same being interpreted to the accused person in Yoruba language by Femi Aina Oladimeji Court Registrar.

My name is Anwal Saleh Magaji. I am an Assistant Superintendent of Narcotics II. I work with the National Drug Law Enforcement Agency Osun State Command. I am the Central Exhibit Officer of the command. I know the accused person.

On 7/8/15 some NDLEA operatives including Hashim Isah Yerima and Makinde Olaposin brought the accused person to my office with some dried substance concealed inside a black sack suspected to be cannabis sativa. I asked the accused person whether the exhibit was his he stated yes. I then conducted a field test on the substance using United Nations kit and the result was positive for cannabis sativa. I weighed the substance. It was 800 grammes. I took a fraction of the substance about 5 grammes and put inside a transparent evidence pouch and sent to our laboratory in Lagos for tests. I issued 3 Exhibit

forms namely Certificate of Test Analysis Form, Packing of Substance and Request for Scientific Aid Test

The accused person thumbprinted the forms and the evidence pouch. I marked the 3 Exhibit forms, the evidence pouch and the bulk substance with a No.

NDLEA/OSSC/129/15. I took the accused person to the interrogation unit where his statement was taken. On 29/1/16 I took the transparent evidence pouch to our office.

On a later date I went back and collected a large brown envelope and a drug analysis report. That is all.
