My name is Omijire Bukola Soji. I am a Chief Narcotics Agent with the National Drug Law Enforcement Agency Osun State Command. I know the accused person. On 16/6/15 at about 1.09 pm a team of NDLEA operatives went to Makun's Hotel along Ilesha road. The accused was

found with 4 parcels containing substances supported to be indian hemp. Accused was arrested and taken to NDLEA office where the substance was tested and weighed. It proved positive to be cannabis sativa and it weighed 4.2kg. after that the accused person signed and thumbprinted the Exhibit forms while the arresting and witnessing officers also thumbprinted.

After this the accused was taken to another office where his statement was taken down after caution. That is all. Earlier on the Exhibit officer took a little bit of the substance and put in a transparent evidence pouch which he took to Lagos for laboratory. After some time my office received a full report of the laboratory analysis.
