I took a small sample of the exhibit and fieldtested it using United Nations testing kit and it proved positive for cannabis sativa. I weighed the said Exhibit and it was 1.3kg. I took a small portion of it and put it inside the transparent evidence pouch marked A1 and labeled it with NDLEA Reference No. NDLEA/OSSC/006/16. Which the accused person thumbprinted and I signed. I also put the same number on the bulk exhibit forms. I issued 3 exhibit forms namely packing of substance form, certificate of test analysis form and request for scientific aid form which the accused
