On 16/11/15 2 NDLEA operatives from Ile-Ife Area Command brought the accused person to my office. They are Olawumi Simeon and Ajala Azeez. They brought the accused person with some substance suspected to be cannabis sativa inside a polythene bag found with the accused. I asked the accused whether it was true and he said yes. I conducted a field test of the substance using United Nations kit and it proved positive to be cannabis sativa. I then weighed the substance and it was 700grams. I took a bit of the substance which I placed inside a transparent evidence pouch for further analysis. I issued 3 Exhibit forms namely Certificate of Test Analysis, Packing of Substance and Request for Scientific Aid form. The accused person signed and thumbprinted the 3 exhibit forms and the 2 officers signed the forms. I marked the 3 exhibit forms, the evidence pouch and the bulk of the exhibit with NDLEA No. NDLEA/OSSC/172/15. I then took the accused person to the investigation room where his statement was recorded in English language. On a latter day 29/1/16 I took the evidence pouch to our National laboratory where I delivered it. Later I collected the drug analysis report and a large brown envelope which I handed over to our office.
