Case for the prosecution opens.

1st prosecution witness.

Sworn on the Holy Bible and states in English language.

My name is Anwal Saleh Magaji. I am an Assistant Superintendent of Narcotics. I work with the National Drug Law Enforcement Agency Osun State Command. I am the Exhibit Officer of the command. I know the accused.

On 17/8/15 2 NDLEA operatives from Ile-Ife Force Command brought the accused person to my office with some quantity of substance suspected to be indian hemp. I asked the accused person about the substance and he stated he was arrested with it. I conducted a field test of the substance using United Nations kit and it proved positive to be cannabis sativa. The substance was brought in 2 bagco bags. The accused person denied one and accepted the other. I weighed the one he accepted and it



was 750 grammes. I took a fraction of the substance which I placed in a transparent evidence pouch for forensic analysis. I issued 3 Exhibit forms namely the Certificate of Test Analysis, Packing of Substance and Request for Scientific Aid Test form.

The accused person signed and thumbprinted the 3 exhibit forms and the evidence pouch which the 2 officers signed. I took the accused person to the interrogation room where he wrote his statement by himself. On 29/1/16 I took the transparent evidence pouch to our National Headquarters in Lagos for forensic analysis.

On a later date I collected a large brown envelope with a drug analysis report. All the 3 exhibit forms and the large brown envelope have a number NDLEA/OSSC/132/15. That is all.

I can identify the 3 Exhibit forms.
